

## Certified Credit Counsellor (CCC) - Ease of Access Kit - IIBF Exam Enrolment

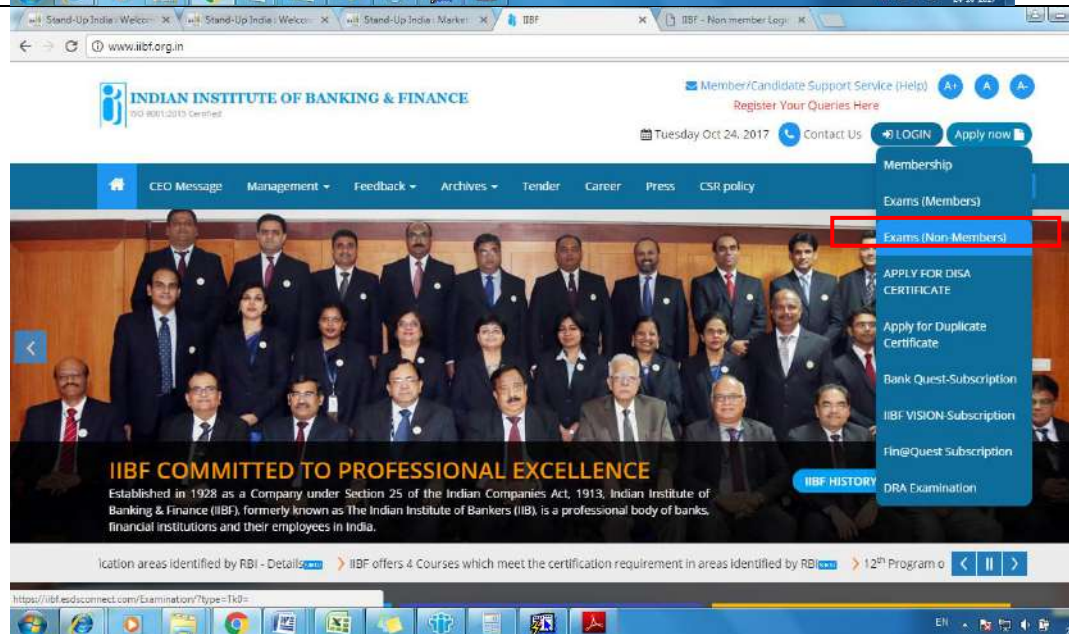
Anyone intending to onboard as CCC has to clear the exam conducted by IIBF. It may be mentioned that registrations are open for the present and exams are scheduled to be held on 17<sup>th</sup> February, 2018. In normal course while examination is being frequently held at Mumbai and Kolkata centres, in other centres these are generally held in every six months.

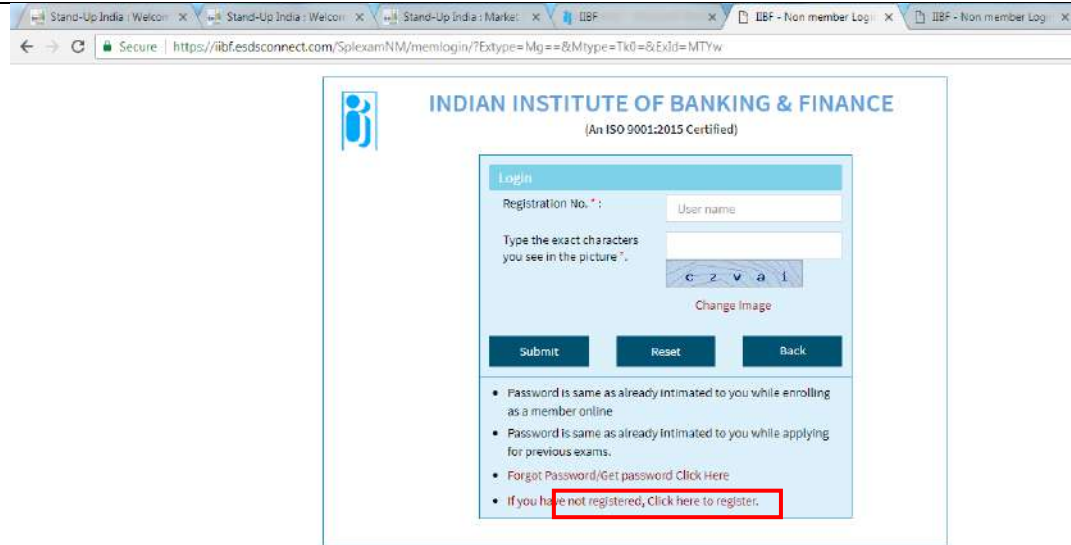
